and South Riverside County to attend, and to enjoy the guided tours following the meeting. Rebecca Farnbach, TVHS president, will be on-hand to officially welcome the CoH to their museum, the Little Temecula History Center, located in the restored barn (see photo, below). **Please note** that the Wolf Barn has neither heat nor AC.

After the meeting, TVHS members will be in the barn, first to interpret the museum displays, then to lead the way to the restored Vail Ranch Headquarters buildings nearby.

The Temecula Valley Historical Society was founded in 2001. The society's projects have included the placement of plaques and markers on historic buildings and sites in Old Town Temecula, the restoration of the Louis Wolf Tomb, the restoration of a stagecoach, and the production of a DVD about their local history. The society provides maps of self-guided walking tours of Old Town Temecula to local shopkeepers, for public distribution.

Who Will Receive These Awards in March? Send-In Award Entries Now for 2018 Conference!

YOU can help to make this happen!

NOW is the time to nominate your hard-working volunteers, staff, or others active in the local-history field, for the Annual Awards to be presented by the Congress of History at our *Annual History Conference*, March 2 & 3, 2018.

The awards will be presented before lunch – some of them on Friday, and the remainder on Saturday, depending on the number of awards to be presented.

These awards are community-wide recognition for people and programs from throughout San Diego and Imperial Counties (and the Baja, Mexico) who have made significant contributions to the preservation and development of our regional history.

There is **NO** form to fill-out, just submit a letter to us giving **YOUR name**, address and phone number, then the title of the award, the person's name, their organization's name (if any) and the reasons why the individual (or group) should receive this specific award.

E-Mail it <u>VERY SOON</u> to the Awards Committee, to Louise Torio at – **historicsandiego@aol.com** or surface mail it (see the address at the end of this article). **NOTE: To be considered for awards, nominations <u>MUST be received or postmarked by Saturday, Feb. 10, 2018</u>.**

You may NOT nominate yourself (but, you may privately request some other person or group to nominate you). You do NOT have to be a member of the Congress of History, or of its member organizations, to be eligible for an award, or to suggest a name for an award. You do NOT have to be a member to attend the conference in March. *The public is welcome to attend! Tell your friends, family, and neighbors!*

NOTE: Any nominations that were received by the Awards Committee in previous years, but were not given an award, <u>must be re-submitted</u> to the Congress of History again this year, if they are to be considered for an award in 2018.

Awards are kept secret, as much as possible, to surprise the recipient. However, we do like to have award winners attend the ceremonies, when we can arrange for that to occur. Therefore, it may be necessary to tell the person (or organization) that they are an award-winner, to be sure that they will be there for the presentation.

Types of Awards Available

NOTE: <u>Awards can only be presented if nominations are received</u>. The following is a list of the awards that might be presented, and the qualifications to receive each award:

The <u>Ben Dixon Award</u> is the Congress of History's most esteemed award for an individual, or couple. It is a significant award for major, long-term contributions to enriching and enhancing the cultural and historical materials of the San Diego region.

The <u>John Montgomery Education Award</u> is for an individual or group contributing significantly to further the actual teaching of local history (in formal classes). Awardee/s must be actual, accredited teacher/s.

The <u>Award of Merit</u> is given to a society or organization for their outstanding effort in the preservation of local history. (More than one may be awarded.)

The <u>Award of Honor</u> is given to an individual or couple for their outstanding effort in the preservation of local history. (More than one may be awarded.)

The <u>Mary Ward Memorial Award for Historic Archives and Records Management</u> is to be presented to an individual or a group for their outstanding effort in the preservation of historical materials. This award was created to remember and celebrate the late S.D. County Historian/Archivist Mary Ward and her many contributions to preserving local history.

The <u>Media Award</u> is to be given to the person or medium that contributes significantly to the preservation and development of the history of this region. This is intended for professional, commercial media (such as newspapers, magazines, radio, television or other communication media) or those who work there.

The <u>Evelyn Kooperman Library Award</u> is to be awarded to any substantial, public or private library collection, or library department, focusing on the preservation of the history of the San Diego, California and Baja California, Mexico, region. Evelyn Kooperman, is a retired San Diego City Librarian. To thank and honor her, after her many years of service as recording secretary of the Congress of History, the Congress created this award and named it

(Continued from Page 1) in the Point Loma neighborhood of San Diego. For over 40 years the PHC has promoted the history and appreciation of the Portuguese immigrants and Portuguese culture in the region.

Because the conference location is just across the street from the Portuguese Museum, conference guests will be invited to visit the Portuguese Museum as well as the beautiful 1922 Portuguese Chapel located next door to the hall. (See a photo of the chapel on page 6. Photo courtesy of the PHC) The chapel was listed on the National Register of Historic Places in February 2017.

The Portuguese community is



currently spearheading the adoption of a Little Portugal District to best preserve and commemorate the accomplishments of this community.

Portuguese Hall has its own parking lot, although we always encourage guests to carpool. Within a block walking distance are many locations for lunch, so lunch is on your own. (At the conference we will provide coffee and light refreshments, as well as a map showing nearby, easy-to-walk-to, local restaurants.)


ego. I've had the honor of working with her, and she has contributed so much of her time." Both Mollie and Darlene are long-time members of the CoH.

Exhibit Table Requirements:

1) The organization/vendor <u>must</u> have a current, paid membership in the Congress of History, for the 2017/18 membership year. Not sure if your group's membership is current? Check with Membership Chair Helen Halmay (her contact information is in the large box on page 2 of every *Adelante*).

2) For 2018, all of the tables will be in the main room, with the speakers. Since those who are seated at exhibit tables will be located in the main room, and able to hear/see the speakers, then they must register/pay to attend the conference, just like everyone else in attendance (including all the volunteers).

- 3) Note: An organizational/business member with an exhibit table may purchase an "organizational/vendor-attendance name tag" (labeled with the **name of the organization or vendor**, rather than the name of a specific person) for alternate table-watchers to use on different days, or at different times throughout the day (especially useful if one person cannot stay all day, or if different people will be manning the table on different days). This money-saving offer is for one name tag <u>per person</u>, per table. So, for example, if there are two people manning the table at the same time, the organization/vendor will need to register and pay for two name tags.
- 4) NOTE: There will be a nominal, good-faith donation of \$10 per each non-profit exhibiting group, to hold your two-day space. Two-day table costs for all for-profit vendors are a \$35 donation to the Congress of History. There is no discount for one-day attendees. To reserve a table, send your name, organization/vendor name, and the check to Helen Halmay (at the PO Box address, above) *ASAP*, preferably *before* you register for the conference.

Voting on Congress of History Officers, for 2018/19, will be at *Annual Meeting*, Sat., Feb. 17

Voting for Congress of History (CoH) officers, for 2018-2019, is open to all individual, student, or senior Congress of History members (one vote each), donor members (one vote each), family members (two votes, one per adult), and one delegate (one vote) from each organizational or business member.

This voting will take place at the Congress of History's *Annual Meeting* to be held on Saturday, February 17, at 10 a.m., The meeting location will be announced in the February edition of *Adelante*.

This Annual Meeting is open to all Congress of History members, and the public (as are the majority of our meetings). However, not everyone attending may automatically vote. Only current, paid members (2017-18) may nominate or vote. (A current, paid membership sign-in check list will be at the door.)

1) Attention voting delegates from a participating organization or business: please bring a letter from your organization or business stating that you are authorized to cast a vote on behalf of your organization/ business. As an organizational/business member, your group must have a current, paid membership, in order to have one voting delegate. President: Serves as the Chief Executive Officer of the Board of Directors and of the general membership. Is responsible for the preparation of meetings, their agendas and the orderly consideration of business relative to the Corporation's mission. Appoints all Standing or Special Committee Chairs, with the approval of the Board of Directors. Serves as an ex-officio member of all Committees, except the Nominating Committee.

Vice President: Assists the President in all duties. In the President's absence, serves as presiding officer over all meetings of the Board of Directors and of the general membership.

Secretary: Takes minutes at all Regular, Annual, and Special Meetings, and submits them for approval at the (Continued on Page 10)

following meeting. Serves as custodian of the Corporation's records (except those specifically assigned to other Board Members), including minutes and/or reports of officers and committee chairpersons. Keeps a copy of the Corporation's Articles of Incorporation, Bylaws, Standing Rules, if any, available for reference at all meetings.

Treasurer: Manages the Corporation's funds; receives all monies from all sources; has check signature authorization for disbursements approved by the Board of Directors; makes payment of all bills when due; and prepares required financial statements. Deposits all monies received in bank accounts to the credit of the Congress. Maintains and keeps records of all business transactions of the Congress. These books and accounts shall be open for inspection by any member in good standing. Is responsible for the preparation and filings of any reports required by the State of California or any other governmental organization regarding non-profit organizations.

Special Events Treasurer: Is responsible for receiving, recording, and transmitting to the Treasurer monies received for fees from the Annual History Conference, Workshops, and other special activities. Disburses funds from the Congress' bank account in pursuance of his or her duties.

Board Members-at-Large: Serve as voting officers of the Board of Directors. Help ensure compliance with Board policies and procedures, and all relevant legal and ethical standards. At the President's request, act as representatives or spokespersons for the Corporation. Perform other duties as directed by the President or the Board of Directors.

• Appointed Officers' Responsibilities •

The President, with the approval of a majority of the Board of Directors, may appoint other officers as needed to fulfill the Congress' Mission. Any two or more appointed offices may be held by the same person.

Appointed Officers shall serve from the day of their appointment until the end of the term of the standing Board of Directors. Appointed Officers are eligible for re-appointment.

Appointed Officers shall not receive any monetary compensation for their services. Additional positions may be appointed by the President and Board of Directors.

Membership Chair – The Membership Chair shall be Chairman of the Membership Committee and, therefore, is responsible for sending-out annual dues notices, and following-up on such notices.

Parliamentarian – The President may appoint a Parliamentarian to advise him or her during his or her term of office.

Archivist/Historian – Keeps all records of the activities of the Congress, including press releases, photographs, programs, and news articles about the Congress, and its activities/members.

All Elected and Appointed Officers shall perform the duties prescribed by the Congress of History's Articles of Incorporation, Bylaws, and Standing Rules, as well as the Parliamentary authority contained within Robert's Rules of Order. Any vacancies of Elected or Appointed Officers shall be filled by a majority vote of the Board of Directors.

Stage Driver Samuel "O. T." Hackett to be Topic of Temecula Valley Program Meeting on Monday, January 22, 6 p.m.

"Nichols, a retired teacher and former docent for the State Parks of California, has a thoughtful regard for the past and brings stories to life with his wit and humor," says Rebecca Farnbach, president of the **Temecula Valley Historical Society** (TVHS), whose Little Temecula History Center museum is located in the Wolf Barn.

The TVHS invites visitors to join them for a social time with free refreshments at 5:30 p.m., prior to the program. There is no charge to attend TVHS programs, and visitors are welcome.

Sensation! Glimmering up from the distant muck was *something!* Sensing pay-dirt, so to speak, the crew carefully brought up 13 bottles and a small light bulb. Crew member Gary Harper dashed into the Grinder and asked owner

Sharon Jones to call your correspondent, which she did. The immortal phrase? "They just found something

Pictographic Clues on the Cultural Landscape of Southern California will be discussed by Author Steve Freers at the SDCAS Meeting on Tues., Jan. 23, at 7:30 p.m.

Pictographic Clues on the Cultural Landscape of Southern California will be the topic when the **San Diego County Archaeological Society** (SDCAS) meets Tuesday, January 23, at 7:30 p.m. in the Los Peñasquitos Adobe County Park. (See photo of the Los Peñasquitos adobe, above.)

Southern California is rich in pictograph and petroglyph evidence of Native American interactions with their landscape. Digital rendering advancements over the past decade have augmented opportunities to expand our understanding of southern California rock art – especially pictographs. In tandem with new site discoveries, we have a better handle on rock art "styles," their distribution, and in some case regional "style" variations. The expressions of rock art along the primary Late Period ethnographic division between *Yuman* and *Takic* speaking groups has been of particular interest recently. Additionally, specific forensic analysis of pictograph impression hand prints has supported conventional suppositions regarding the makers of certain types of rock art.

This visually-rich presentation, by rock art researcher and author Steve Freers, will demonstrate how much of this new information aligns with examples of pictographic rock art comprising the La Rumorosa, Rancho Bernardo, and San Luis Rey Styles.

The Los Peñasquitos Adobe is located off Black Mountain Road, beyond Canyonside Community Park, at the end of the entry road. Free parking is available in a gravel lot, near the barn.

Now, when a fragile, possibly-historic discovery is made, the guys know just what to do – alert Helen Ofield! And, of course Sharon Jones, at the Grinder Deli, could call Helen immediately, as Sharon is a LG Historical Society member, too. Way to go team! Bring your Mom, Grandpa, kids, etc. and share this weekend of love with those you care about. Guests will board the newly-constructed galleon *San Salvador*, for a three-hour scenic tour of the Big Bay, marine wildlife, and local attractions.

During the *Sweetheart Sail* enjoy a relaxing afternoon on the water, or join in the sailing adventure by helping the crew sail the ship by hauling halyards and tending sheets (sails). MMSD will have champagne, treats, and a souvenir gift for

the enjoyment of the guests on board.

The *Californian* is a replica of a 1812 revenue cutter, the government's ship of choice during the California Gold Rush era. The *San Salvador* is a replica of the galleon that, under the command of Juan Rodriguez Cabrillo, arrived at the port we now call San Diego on September 28, 1542.

Sailing on the *Californian* costs \$70 per adult; \$48 per child, ages 3 to 12 (children must be accompanied by an adult); a child 2 and under is \$10. (Ticket does not include museum.)

Sailing on the San Salvador costs \$99 per adult; \$59 per child, ages 3 to 12 (children must be accompanied by an adult); a child 2 and under is \$20. (Ticket does not include museum admission.)

the back of Gary's truck was the "Olive Street 13" unbroken, unchipped, uncracked, and dating from circa 1900 - 1930. Even the little light bulb, though half full of brown water, was undamaged!

The century-old well (or septic tank, or outhouse) had protected its treasure to a fare-thee-well. We'll have to check a couple of old maps to know who owned the land in the early 20th century.

The star of the group is a tall, green, wavy glass bottle embossed with "Pluto Water America's Physic." A little devil, replete with tail, spear and pointy ears, is embossed on the underside of the base: "Pluto." You remember him, the Roman god of Hades. Pluto Water was bottled at French Lick, Indiana, home of many a mineral spring whose cleansing and laxative qualities made Pluto Water a popular item in the Pluto Bar of the French Lick Hotel. America embraced the devilish brew: Reportedly, it took 19 rail cars in 1919 to haul boxes of the beverage across the land. As everyone knows, French Lick is named for a big salt lick once favored by migrating animals, including French explorers and their horses.

But, wait, there's more: Three Heinz sauce bottles with "57" embossed on the underside. Heinz got going in Pittsburgh in the mid-19th century and "57" stood for any number of ingredients in its pickles, ketchup and sauces. Reportedly, if you thumped on the 57 on the bottom, out came the ketchup in a steady stream.

There is an amber beauty embossed "Purex" for the famous detergent, still used nationwide (these bottles are selling on e-Bay for \$6 - \$25). Other bottles are unmarked, but have charming shapes.

And that little light bulb? The socket is gone and the filaments corroded, but amazingly it's uncracked. It's probably an Edison (but without his trademark nipple on the top). It'll take some doing to clean them up with soft brushes, old toothbrushes, vinegar, bleach water, tepid water (too cold or too hot can cause cracking). [See a photo of the group on page 11, courtesy of Lemon Grove Historical Society.]

But stay-tuned, as these treasures are destined for the Sonka Store exhibit in the Parsonage Museum, home of the **Lemon Grove Historical Society** (LGHS). There's a good chance that the whole set of bottles was purchased at the Sonka store (today, Lemon Grove Bakery), which operated 1907 – 1947. The Parsonage Museum is located in Civic Center Park, at 3185 Olive, open Saturdays 11 a.m. to 2 p.m. by donation, free off-street parking.

Yesterday was a good "old day" as much for the bottle discovery as for the delight and quick-wittedness of our city crew, which knew a good thing when they saw it! This whole sequence of events is one of the joys of living in a small town. (BTW, did you know that only about a dozen great guys, helmed by Tom Bell, hold civic infrastructure together for some 26,000 residents here?)

We haven't had so much fun since a Caltrans crew brought us that 40 million-year-old whale bone in 2002 while building Route 125! (For more information about the LGHS, see their new website at: www.lghistorical.org.)

Alpine Railway — Train, Tracks and Stations — are headed South; Next Stop: PSRM, in Campo

A train is making its way from Alpine to Campo, but how it's getting there and why is a little off the beaten track. Roy Athey's full-sized, backyard industrial train — along with the train tracks, flagman signals, switches, three buildings and other train-related equipment — are headed for the Campo Railroad Park and Museum of the **Pacific Southwest Railway Museum** [PSRM, a long-time organizational member of the Congress of History].

Most of the items in his yard are being taken apart by [PSRM] volunteers and will be trucked to their new home over several trips. A caboose of Athey's is already settled at the site.

Athey, 86, began building the train setup on part of his 2.5 acres of land with friends Casey Derengowski and Jerry Petriozzi after he retired from the San Diego County Probation Department in 1988.

A model train enthusiast and train historian, he opened *Descanso*, *Alpine & Pacific Railway* to the public in May 1990. The railway consists of a 1935 Brookville locomotive and riding car, five stations, a blacksmith's quarters and a 100-foot-long train trestle that gives riders scenic views of the Cuyamaca and Palomar mountains.

Over the years, Athey estimates, he has given nearly 15,000 free rides. Every Sunday afternoon from 1 to 3 p.m., Athey would put on his engineer cap and regale visitors with stories about how railroads work; the sizes of rails, telegraph and telephone systems; about switch lamps and a variety of other rail-related items while traveling a quarter-mile up and back on the tracks. Many of his items come from trains no longer in service across the United States. He has recycled many odds and ends and given them new life. Some of Athey's tracks date back to 1887 and were manufactured in Germany and Japan.

But Athey says the time has come for the train to move to a bigger yard. His knees don't allow him the freedom of movement he once had, and neither of his two sons expressed interest in keeping the ride going. So the railroad park in Campo is the right place for his labor of love, and where he knows that railroad traditions continue. "We talked about it a year or so ago," Athey said of conversations he had with Jim Lundquist, director of museum services for the Pacific Southwest Railway Museum Association. "I had pretty much decided then that that's where it was all going to go someday. I knew that's where people can learn and will keep enjoying themselves on the train."

Lundquist said the train and its companion items will be set up on museum property adjacent to the Campo depot and operated as a new exhibit and ride. "We'll be demonstrating how mines and mine railroads and industrial railroads played an important role in the development of San Diego County and the surrounding regions," Lundquist said.

Alpine resident Jennifer Doucet said she is looking forward to seeing Athey's train keep rolling in Campo. "His gift to the Pacific Southwest Railway in Campo is a continuum of his generosity and his passion for train transportation," Doucet said. "We must have visited his train depot and taken a complimentary ride over five times. "And with every trip, his love for his train and historical accuracy exuded from him with every story, every memory shared. I imagine he knows that by giving it to the Campo Museum, he's certain that it will have a home with other train enthusiasts and it will continue to tell the story of our past."

Lundquist says the museum is greatly appreciative of the gift, especially knowing how near and dear to his heart the train, and all its accessories, are to Athey. Lundquist, an Alpine resident who has been friends with Athey for decades, said Athey's love affair with railroads is well-known. He noted that when Athey retired from his job as a probation officer in the late 1980s, his colleagues gave him a retirement plaque. "It reads, 'Thanks, Roy, for keeping us on track,'" Lundquist said.
