Facts About Lemon Grove

The Parsonage Museum and the Cultural Center offer a glimpse into the development of what was once known as the "main entrance to the San Diego Metropolitan Empire." Before the interstate freeways - before the first airport - miners heading for Julian gold and travelers crossing the desert from Yuma passed through this "gateway to San Diego" along the Lemon Grove road.

The first stage station is gone, now, but a re-creation of the first train depot lives-on as the trolley depot in the town center. The first church building in Lemon Grove still stands in Civic Center Park. It's the modern-day

partial re-creation inside the Parsonage Museum. Get the whole story on the award-winning, five-panel Lemon Grove History Mural, displayed on the south side of the bakery building, at 3308 Main St. (facing Pacific). And, don't miss the "Giant Lemon," a monument to the days when Lemon Grove was a sea of lemon orchards.

Parsonage Museum Exhibits

The charming, lemon-yellow Parsonage Museum (see photo, above) presents both long-standing exhibits (central to the understanding of Lemon Grove's history) and rotating displays highlighting special topics from their archives, photo collection, and special collections. In this way they strive to keep their museum fresh and ever-changing.

• **Standing Exhibits:** The Parson's Study; the Sewing Room, Parents' Room, Children's Room (on the 2nd floor); and the Treganza Gallery of Artwork (also on the 2nd floor).

LAST CHANCE for Award Entries!

Now is your last chance to nominate your hard-working staff and/or volunteers for the *Annual Awards*, to be presented by the Congress of History at our History Conference, March 13 and 14, 2020. This year the awards may be presented on both Friday and Saturday, depending on the number of nominations received. Nominate someone! You'll feel the happiness of recognizing a deserving person!

You do *not* have to be a member of the Congress of History, nor of its member organizations, to be eligible for an award, or to nominate a name for an award.

You may NOT nominate yourself, but may request some other person or group to nominate you. (Nominations that were submitted last year that did not receive awards need to be re-submitted for this year.)

Qualifications – These awards are recognition for people, programs, and organizations from throughout San Diego and Imperial Counties that have made significant contributions to the preservation and development of regional history. There is NO form to fill-out, just submit a letter to us giving **your name**, **address**, **phone number**, **and e-mail address** (as the person or group making the nomination), then the title of the award, the name of the person/s or group being nominated, organizational name (if any) and the reason/s why the individual or group should receive this specific award.

Mail or E-mail your nomination/s <u>IMMEDIATELY</u> to the Awards Committee (see the address at the end of this article). Because we are splitting the awards presentation between Friday and Saturday, we will be notifying the person, or group, that they are award recipients, in order to have them in attendance on their specific day.

Types of Awards - The following is a list of the awards that may be presented:

The <u>Ben Dixon Award</u> is the Congress of History's most esteemed award for an individual. It is a significant award for **major**, **long-term contributions** to enriching and enhancing the cultural and historical materials of the San Diego region.

In the past 50+ years, the **Ben Dixon Award** has gone to many outstanding individuals and couples who have made, and are making, important contributions to the history of our region.

The <u>John Montgomery Education Award</u> is for an individual (teacher/administrator) or a group contributing significantly to further the teaching of local history (in actual, formal classes).

The **Award of Merit** is given to a society or organization. (More than one may be awarded.)

The **Award of Honor** is given to an individual. (More than one may be awarded.)

The <u>Mary Ward Memorial Award for Historic Archives and Records Management</u> is to be presented to an individual or group for their outstanding effort in the preservation of historical materials. This award was created to remember Mary Ward and her many contributions.

The <u>Media Award</u> is to be given to the person or medium whose media work has contributed significantly to the preservation and development of the history of this region. This is intended for professional, commercial media (such as newspapers, magazines, radio, or television) or the people who work with these media.

The <u>History Trailblazer Award</u>, has been created to honor founding/early members of the Congress of History.

The <u>Evelyn Kooperman Library Award</u> — The Congress of History's former recording secretary, Evelyn Kooperman, is a retired San Diego City Librarian. To thank and honor her, after her many years of service as secretary of the Congress of History, the Congress created this award. This is to be awarded to any substantial, public or private library collection, or library department, focusing on the preservation of the history of the San Diego, California and Baja California, Mexico, region.

The <u>Richard Hann Collegiate Award</u> – A Congress of History past-president, Richard Hann is a retired college professor. To honor and thank him for over 10 years of service as our presiding officer, and to acknowledge his interest in encouraging the involvement of younger Congress members, the Congress created this award. This is to be awarded to a currently-enrolled college level student, graduate student, or group of students, involved in local history projects designed to preserve the history of the San Diego, California, and Baja California, Mexico, region.

Voting on Congress of History Officers, for 2020/21, will be at *Annual Meeting*, Sat., Feb. 15

Voting for Congress of History (CoH) officers, for 2020-2021, is open to all individual, student, senior, or life Congress of History members (one vote each), donor members (one vote each), family members (two votes, one per adult), and one delegate (one vote) from each organizational or business member.

This voting will take place at the Congress of History's *Annual Meeting* to be held on Saturday, February 15, at 10 a.m., at the historic H. Lee Toudor Revival House Museum and Cultural Center. The **Lemon Grove Historical Society** will host. Further details will be given in the February edition of *Adelante*.

This *Annual Meeting* is open to all Congress of History members, and the public (as are the majority of our meetings). However, not everyone attending may automatically vote. Only current, paid members (2019-20) may nominate or vote. (A current, paid membership sign-in check list will be at the door.)

1) Attention voting delegates from a participating organization or business: If you are a NEW delegate, please bring a letter from your organization or business stating that you are authorized to cast a vote on behalf of your organization/business. As an organizational/business member, your group must have a current, paid membership, in order to have one voting delegate. Not sure if you're the official delegate, or if your group's membership is current? Ask your group's officers, or ask CoH Membership Chair Helen Halmay (see her contact information in #2, below).

NOTE: If you receive *Adelante* through an organizational membership, you may not nominate, or vote, **unless you are the official delegate from your organization**. However, you are *very welcome to attend* the meeting, and join in discussions! (Our meetings are open to the public.) For voting purposes, a list of current, paid members will be checked, at the meeting.

President: Serves as the Chief Executive Officer of the Board of Directors and of the general membership. Is responsible for the preparation of meetings, their agendas and the orderly consideration of business relative to the Corporation's mission. Appoints all Standing or Special Committee Chairs, with the approval of the Board of Directors. Serves as an ex-officio member of all Committees, except the Nominating Committee.

Vice President: Assists the President in all duties. In the President's absence, serves as presiding officer over all meetings of the Board of Directors and of the general membership.

Secretary: Takes minutes at all Regular, Annual, and Special Meetings, and submits them for approval at the

following meeting. Serves as custodian of the Corporation's records (except those specifically assigned to other Board Members), including minutes and/or reports of officers and committee chairpersons. Keeps a copy of the Corporation's Articles of Incorporation, Bylaws, Standing Rules, if any, available for reference at all meetings.

Treasurer: Manages the Corporation's funds; receives all monies from all sources; has check signature authorization for disbursements approved by the Board of Directors; makes payment of all bills when due; and prepares required financial statements. Deposits all monies received in bank accounts to the credit of the Congress. Maintains and keeps records of all business transactions of the Congress. These books and accounts shall be open for inspection by any member in good standing. Is responsible for the preparation and filings of any reports required by the State of California or any other governmental organization regarding non-profit organizations.

Special Events Treasurer: [This position is proposed to be removed. See the article on page 15.] Is responsible for receiving, recording, and transmitting to the Treasurer monies received for fees from the Annual History Conference, Workshops, and other special activities. Disburses funds from the Congress' bank account in pursuance of his or her duties.

Board Members-at-Large: Serve as voting officers of the Board of Directors. Help ensure compliance with Board policies and procedures, and all relevant legal and ethical standards. At the President's request, act as representatives or spokespersons for the Corporation. Perform other duties as directed by the President or the Board of Directors.

The President, with the approval of a majority of the Board of Directors, may appoint other officers as needed to fulfill the Congress' Mission. Any two or more appointed offices may be held by the same person. Appointed Officers shall serve from the day of their appointment until the end of the term of the standing Board of Directors. Appointed Officers are eligible for re-appointment. Appointed Officers shall not receive any monetary compensation for their services. Additional positions may be appointed by the President and Board of Directors.

Membership Chair – The Membership Chair shall be Chairman of the Membership Committee and, therefore, is responsible for sending-out annual dues notices, and following-up on such notices.

Parliamentarian – The President may appoint a Parliamentarian to advise him or her during his or her term of office.

Archivist/Historian – Keeps all records of the activities of the Congress, including press releases, photographs, programs, and news articles about the Congress, and its activities/members.

All Elected and Appointed Officers shall perform the duties prescribed by the Congress of History's Articles of Incorporation, Bylaws, and Standing Rules, as well as the Parliamentary authority contained within Robert's Rules of Order. Any vacancies of Elected or Appointed Officers shall be filled by a majority vote of the Board of Directors.



Recognizing Black History Month, Pacific Southwest Railway Museum displays 'Jim Crow' Railcar

The **Pacific Southwest Railway Museum** (PSRM) has on display a fully-restored, racially-segregated "Jim Crow" railroad car at its Campo living-history and train-operation center. With paid admission, the car is open to the general public for viewing in the Display Building, in the PSRM campus, located just off Highway 94 at Forrest Gate Rd., Campo, in the high desert of East San Diego County.

Restoration of this historic, segregated railcar took nine years of volunteer effort to bring the 1886 wooden passenger/baggage car to its 1936 appearance. This historic car is one of just a handful of restored "Jim Crow" cars in the U.S. and the only one west of the Mississippi. The extensive work included recasting and replacement of many of the ornate cobalt-blue clerestory windows, replacement of the well-worn red plush upholstery, and the exquisite recreation of the original, nickel-plated oil ceiling lamps. In addition, much woodwork was

performed on the car — originally built by the Pennsylvania Railroad in its massive Altoona, Penn. shops complex. It was eventually retired and sold second-hand to several small railroads in the segregated Deep South. In compliance with state laws at the time, the car was fitted with a partition separating the "white" seats from the "black" seats. Later, all of the black seats were removed and that space converted to a "baggage and express" section, with a new partition added to the "white" section, to separate eight black seats from the remaining white seats.

In 1945, 20th Century Fox purchased the car and other period railcars and locomotives for use in "B-grade" Western films. In 1976, the car (along with one of its sisters) was acquired by the PSRM railroad museum and trucked initially to Poway, then to the museum's Campo site, after that property was acquired in 1980. This historic railcar may viewed in the Display Building, when touring the PSRM campus with a paid admission to the museum grounds.

Nathan Harrison: Born a Slave, Died a San Diego Legend; Exhibit to open in Spring 2020 at the S. D. History Center

Few people in the history of the United States embody ideals of the American Dream more than legendary African American San Diego homesteader Nathan Harrison (d. 1920). Harrison was a freed slave originally from Kentucky who lived in a small cabin on Palomar Mountain, in northeastern San Diego County, from the 1850s to 1920. His is a story with prominent themes of overcoming obstacles, forging something-from-nothing, and evincing gritty perseverance. In a lifetime of hard-won progress, Harrison survived the horrors of slavery in the Antebellum South, endured the mania of the California Gold Rush, and prospered in the rugged chaos of the Wild West.

Developed in partnership with San Diego State University, this new exhibition at the **San Diego History Center** (SDHC), in Balboa Park, offers recent discoveries from archaeological excavations at the Nathan Harrison cabin site, combined with in-depth research of historical accounts, to offer new insights and perspectives into his biography, while also providing a fresh glimpse of everyday life in San Diego during the Civil War, Reconstruction, the Gilded Age, and the Progressive Era. In this interactive exhibition, visitors will experience the bumpy journey up Palomar Mountain to visit Nathan Harrison in his cabin, view artifacts to help solve historical mysteries concerning Harrison's private life, see archaeologists at work on the mountain, and participate in a mock excavation.

The struggles and hardships that Nathan Harrison faced were likely typical for ex-slaves such as himself, and his story offers insights into the broader experiences of Southern California's African American community. However, as *Born a Slave*, *Died a San Diego Legend* will show through the close examination of what we know about one man's life, Harrison's response and actions were extraordinary indeed. Using historical research, stories, and archaeological findings, this exhibition weaves together a narrative of Nathan Harrison and his ability to counter prejudice to achieve acceptance by the many different communities he encountered. 

Proposed ByLaws Changes to be voted on by CoH Membership *THIS* Sat., at Feb. 15 *Annual Meeting*

ELECTIONS: THIS Sat.! Feb. 15, **2020** The Board approved two proposed changes to the Revised 2012 Congress of History Bylaws, when it met at the September 21, 2019 Board Meeting.

The Congress of History Bylaws state that all proposals must be published in advance and voted on at the *Annual Meeting* (which this year will be held *THIS* **Saturday**, **February 15**, 2020). *Your vote counts*, so please plan to attend that February meeting. (For more details about the *Annual Meeting*, see the front cover, and voting article page 11.)

The first proposal is to eliminate the **Special Events Treasurer** position on the Congress of History Executive Board. The Treasurer can manage all funds for disbursals and deposits related to the annual Congress of History Conference. When the main form of communication was surface-mail (U.S. Postal Service), the conference chair needed to have conference funds going directly to and from the chair for timely payments and updated conference registration information. The internet and mobile devices have made the Special Events Treasurer position obsolete.

The second proposal is to have the **outgoing President** serve as a non-voting member of the Board for one year. The objective is to smooth the transition for the incoming President. Some organizations have the incoming President serve one year as the vice president before actually taking-over. Other groups have an immediate past president to provide assistance during this transition year. We have chosen this second option.

There are no proposed changes to the 2012 Revised Standing Rules, therefore they are not included here (below).

BYLAWS OF THE

CONGRESS OF HISTORY OF SAN DIEGO AND IMPERIAL COUNTIES A NONPROFIT CORPORATION

ARTICLE 1-NAME

1.1 The name of this Corporation shall be THE CONGRESS OF HISTORY OF SAN DIEGO AND IMPERIAL COUNTIES (hereinafter referred to as the "Corporation").

ARTICLE II-OFFICES

- 2.1 The Corporation's principal office shall be located in the County of San Diego, California.
- 2.2 The registered office may be, but need not be, identical with the principal office.
- 2.3 The Corporation shall have a registered agent whose office is identical with the registered office, as is required by the California Nonprofit Public Benefit Corporation Law (Title I, Division 2, Section 9000 et seq. of the California Corporations Code).

ARTICLE III-MISSION

- 3.1 The Corporation's Mission is to provide unity among and to coordinate the educational efforts of other organizations interested in promoting a greater awareness of the history of San Diego and Imperial Counties and outlying regions among its members and the general public.
- 3.2 The Corporation will seek to fulfill its Mission through meetings, workshops, outreach programs, publications, electronic media, conferences, and other activities as authorized by the Corporation's Board of Directors.

ARTICLE IV-MEMBERSHIP

- 4.1 The Corporation shall be composed of Members in Good Standing as defined in the Corporation's Standing Rules, which are attached to these bylaws.
 - 4.2 Membership List
 - (a) The Corporation shall maintain a current Membership List.
 - (b) The Membership List or any part thereof shall not be used by any person for any purpose not reasonably related to the Corporation's purposes.
 - 4.3 Dues
- (a) In order to be Members in Good Standing within the Corporation, members must pay the annual dues for their classification.
- (b) The Corporation's Board of Directors may, at its discretion, set different Membership classifications, annual dues, fees, and assessments.

- (c) The Corporation's Standing Rules shall describe the types of Membership classifications, dues, fees, and assessments.
 - 4.4 Voting Rights

(Revised September 21, 2019)

- (a) Each Member in Good Standing shall be entitled to one vote on each matter submitted for a vote by the members of the Corporation at its Annual Meeting or at a Special Meeting.
- (b) A Member in Good Standing shall have the right to vote, as set forth in these Bylaws, on the following:
- i. Electing Officers of the Corporation's Board of Directors
- ii. Amending and/or rewriting the Corporation's bylaws
- iii. Any motion to dissolve the Corporation.
- (c) Members shall have all rights afforded under the California Nonprofit Public Benefit Corporation Law.
- 4.5 Resignation. Any member may resign by forwarding a letter of resignation to the Membership Chairperson.
- 4.6 Termination of Membership. A simple majority of the Corporation's Board of Directors may vote to suspend or terminate a member's membership for cause after an appropriate hearing. Examples of cause may include misconduct or unethical behavior. Such action must be in accordance with the due process requirement of the California Nonprofit Public Benefit Corporation Law.
- 4.7 Reinstatement. Upon written request to the Board of Directors, a resigned or terminated member may be reinstated, at the discretion of the Board of Directors.
 - 4.8 Disciplinary Action. Such action, if deemed advisable, can be taken as provided in Robert's Rules of Order. ARTICLE V BOARD OF DIRECTORS
 - 5.1 Purpose
- (a) The purpose of the Board of Directors is to manage the affairs of the Corporation subject to any limitations contained in its Articles of Incorporation and Bylaws, California Nonprofit Public Benefit Corporation Law, as well as other federal, state and/or local laws.
- (b) All elected and appointed officers shall perform the duties prescribed by the Corporation's current and subsequently amended Articles of Incorporation, Bylaws, and Standing Rules, as well as the Parliamentary authority contained within Robert's Rules of Order.
- 5.2 Composition. The Board of Directors shall be comprised of Elected and Appointed officers who are individual Members in Good Standing of the Corporation.
- 5.3 Elected Officers. Elected Officers shall consist of the following: President, Vice-President, Secretary, Treasurer, and three Members at Large.
- (a) These officers shall be elected annually by a simple majority of members present at either the Corporation's Annual Meeting, or at a Special Meeting.
- (b) Elected Officers shall serve for one year from the day of their election until their successors have been chosen and seated.
 - (c) All current and former Officers are eligible for re-election.
- (d) Elected Officers shall not receive any monetary compensation for their services, nor exploit their positions for personal gain.
 - 5.4 Elected Officers and Their Duties
 - (a) President
- i. Serves as the Chief Executive Officer of the Board of Directors and of the general membership. Is responsible for the preparation of meetings, their agendas and the orderly consideration of business relative to the Corporation's mission.
- ii. Appoints, with the approval of a majority of the Board of Directors, other non-elected officers as needed to fulfill the Corporation's mission.
 - iii. Appoints all Standing or Special Committee Chairs, with the approval of the Board of Directors.
 - iv. Serves as a voting member of all Committees, except the Nominating Committee.
 - v. Serves as a non-voting member of the Board of Directors for one year upon election of a new President.
 - (b) Vice President

Edna Koons, a founding member of the Lakeside Historical Society (LHS) and recipient of the CoH's 2016 Ben Dixon Award, has died at the age of 105.

She received our highest award for her incredible dedication to researching and sharing the history of Lakeside. What began as a quest to organize boxes of newspaper clippings, photos, and scribbled notes about Lakeside was the beginning of the society's archives collection, which has now grown to more than 300 scrapbooks.





by Betty McMillen, Lakeside Historical Society

Edna Kouns was born in 1914 at her grandmother's house in San Diego. She passed away on February 5, 2020 at her home in Lakeside, with family members around her. Edna was one of the founders of the historical society and was always active in it. She attended the Archives Committee every Wednesday, where clippings were saved in notebooks. Everyone enjoyed hearing her stories about growing up in Lakeside ... how it was a 100 years ago.

Edna survived the 1916 "Hatfield the Rainmaker" flood when she was only four years old. The family home in El Monte Valley washed down river. [Prior to this loss of their home] her mother loaded-up Edna and a new baby into a horse-drawn wagon with their worldly possessions. Her father rode horseback and herded the family dairy cows. They drove up Mussey Grade Road, turned left at Santa Ysabel and headed to the Imperial Valley to live.

Her family came back to live in El Monte Valley when Edna was in the second grade. She attended elementary school in a horse shed and graduated from Grossmont High





She married Erman Kouns in her parents' home in 1936. They had three children. They formed the Lakeside Silver Grey Granite Company and shipped the very rare and beautiful granite to all parts of the US. They supplied the granite that was used for the "Guardian of the Waters" statue at the San Diego County Civic Center. Each day when Erman worked at the Granite company, he would bring home the rejects ... stones that had a flaw ... that could (Continued on the Bottom of Page 26)

- i. Assists the President in all duties.
- ii. In the President's absence, serves as presiding officer over all meetings of the Board of Directors and of the general membership.
 - (c) Secretary
- i. Takes minutes at all Regular, Annual, and Special Meetings, and submits them for approval at the following meeting.
- ii. Serves as custodian of the Corporation's records (except those specifically assigned to other Board or Committee members), correspondence, and reports of officers and committee chairpersons.
 - iii. Keeps a copy of the Corporation's Articles of Incorporation, Bylaws,

Standing Rules, meeting minutes and correspondence available for reference at all meetings.

- (d) Treasurer
- i. Manages the Corporation's funds; receives all monies from all sources; has check signature authorization for disbursements approved by the Board of Directors; makes payment of all bills when due; and prepares required financial statements.
 - ii. Deposits all monies received in bank accounts to the credit of the Corporation.
- iii. Maintains and keeps records of all business transactions of the Corporation. These books and accounts shall be open for inspection by any Member in Good Standing.
- iv. Is responsible for the preparation and filings of any reports required by the State of California or any other governmental organization regarding nonprofit Corporations.
 - (e) Members at Large
 - i. Serve as voting officers on the Board of Directors.
 - ii. Help ensure compliance with Board policies and procedures, and all relevant legal and ethical standards.
 - iii. At the President's request, act as representatives or spokespersons for the Corporation.


- iv. Perform other duties as directed by the President or the Board of Directors.
- 5.5 Appointed Officers
- (a) The President, with the approval of a majority of the Board of Directors, may appoint other officers as needed to fulfill the Corporation's Mission.
- (b) Such Appointed Officers will have the authority to perform such duties as defined in the Standing Rules attached to these Bylaws.
 - (c) Any two or more appointed offices may be held by the same person.
- (d) Appointed Officers shall serve from the day of their appointment until the end of the term of the Board of Directors.
 - (e) Appointed Officers are eligible for re-appointment.
- (f) Appointed Officers shall not receive any monetary compensation for their services, nor exploit their positions for personal gain.
 - 5.6 Executive Committee
 - (a) This Committee shall consist of the Corporation's current Elected Officers.
- (b) The Committee shall have the power to act for the Board of Directors between the Regular Meetings of the Board of Directors.
- (c) A simple majority vote of the Executive Committee members, either in person or via electronic mail or telephone, shall be needed for a motion to pass.
 - (d) The Executive Committee cannot modify any action taken by the Board of Directors.
- (e) Regular minutes of any meetings of the Executive Committee shall be kept and all actions of the Committee shall be reported to the Board of Directors at the latter's next scheduled meeting.
- 5.7 Manner of Acting. All Elected and Appointed Officers shall perform the duties prescribed by the Corporation's Articles of Incorporation, Bylaws, and Standing Rules, as well as the Parliamentary authority contained within Robert's Rules of Order.
 - 5.8 Cessation of Term/Vacancies.
- (a) A simple majority of the Board of Directors may vote to suspend or expel a Board Member for cause after an appropriate hearing at an Annual, Regular, or Special Meeting.
- (b) Examples of cause may include non-payment of dues, misconduct, or unethical behavior. Such action mustbe in accordance with the due process requirement of the California Nonprofit Public Benefit Corporation Law.
 - (c) Any vacancies of Elected or Appointed Officers shall be filled by a majority vote of the Board of Directors. ARTICLE VI COMMITEES
- 6.1 Formation. The President, with the approval of a majority of the Board of Directors, may appoint such ad hoc, standing, or special committees as are required, at any time during the term of office.
- 6.2 Duration. Such committees shall automatically terminate at the close of the business year in which they were appointed, or at the termination of the project for which they were appointed. Examples of Committees are listed and defined in the Corporation's Standing Rules.

ARTICLE VII - NOMINATIONS

- 7.1 Nominating Committee. The President, with the approval of a majority of the Board of Directors, shall appoint a Nominating Committee consisting of no fewer than two (2) Members in Good Standing, and shall designate one as Chairperson.
- 7.2 Duties. The Nominating Committee shall review candidates and make and present nominations for the offices of President, Vice President, Secretary, Treasurer, and three (3) Members at Large. Members of the Nominating Committee are not barred from becoming nominees for offices.
- 7.3 Acceptance of Nomination. It shall be the responsibility of the Chairperson of the Nominating Committee to contact all nominated persons to obtain their agreement to serve, if elected.
- 7.4 Date of Presentation of Slate. Nominations shall be presented at the Annual Meeting held in February. The location of the meeting and the slate of officers must be announced at least one month prior to the Annual Meeting.
- 7.5 Nominations from the Floor. Following the presentation of a proposed slate by the Nominating Committee, nominations may be made from the floor by any member. All such nominees must agree to serve, if elected.



9th Annual S. D. Adobe Home Tour on Sunday, March 22, 10:30 a.m. to 4 p.m., celebrates Rancho Santa Fe & Escondido

Romance of the Rancho is the theme for the 9th Annual San Diego Adobe Home Tour. The 2020 tour celebrates the rich Spanish-Mexican rancho heritage by opening the doors to four beautiful adobe homes and properties in Rancho Santa Fe and Escondido. The tour will showcase the 1831-built Osuna adobe ranch. It also features the home and gardens of a 1926-built home overlooking Lake Hodges that was featured in the October 2019 edition of San Diego Home/Garden. Adobe haciendas and ranch houses sprinkled throughout the rolling hills of North San Diego County serve as enduring reminders of the region's Spanish-Mexican rancho heritage. The 9th Annual San Diego



Much of our local adobe rancho history has crumbled into ruins. However, this was a trend that changed course at the turn of the 20th century, when gentlemen farmers looking to escape urban life moved into the area to plant citrus groves in Escondido and develop equestrian facilities in Rancho Santa Fe.

With a renewed interest in a simple life where handicraft and living close to nature was emphasized, landowners and their architects restored abandoned adobe structures and built new hacienda-style and Spanish Revival homes using bricks of native adobe mud.

March 2020 Tour to showcase 1831 Osuna Adobe

This year's tour showcases the 1831-built Osuna adobe, situated on the old Mexican Rancho San Dieguito land grant, near what is today the village of Rancho Santa Fe. In 1924, a wealthy business

owner, seeking to breed Kentucky racehorses, commissioned architect Lillian Rice to oversee the restoration and rehabilitation of the old adobe home. The property today is a horse-boarding and -training facility; This tour offers an opportunity to view the house (which is rarely open to the public) within a working horse ranch. Further along on the Del Dios Highway linking Rancho Santa Fe and Escondido, Louis M. Richard, geologist for Gladding McBean and Company, built a ranch house for himself and his family in 1926. (See the Mexican-style patio with fountain, right. Photo by Don Bartletti.)



The "beautiful Spanish home" with a view overlooking Lake Hodges features an adobe-and-stucco structure blending Mexican-patio rancho and Spanish Revival styles, hidden behind extensive gardens reflecting the changing moods and lighting of each passing day. The popularity of adobe ranch homes enjoyed another revival in the 1950s, though smaller in scale and in urban and suburban settings.

The romance of these adobe homes is represented by the use of rough-cut beams, tile roofs, practical floorplans, and commanding views.



In Escondido, the tour will feature a 1958 adobe ranch-style hacienda built by Weir Bros. Adobe Company. For several decades, this expansive family home functioned as a place for community fundraising and entertainment. The current owners have decorated with Mexican and Spanish folk art and a bright Mexican palette that evokes an earlier time.

Nearing the end of this midcentury era of adobe construction, a local dentist designed and built an adobe in Escondido as an investment property. The sprawling hacienda-style house was built in 1982, with numerous fireplaces and post-modern construction, while incorporating the classic features of the traditional ranch style home.

The Osuna Ranch and the three homes on this *9th Annual Adobe Home Tour* represent the entire spectrum of San Diego County's adobe heritage. Tickets are available *NOW*, online, at: http://adobehometour.com. (See more tour details at the bottom of this page.)

The Story of Modern Adobe Construction

Modern adobe construction wasn't rare in San Diego's North County, but it also wasn't common – until a revival in the late 1940s. In the mid-20th century, it became so popular in the region that today the Escondido area has the highest concentration of adobe homes and structures anywhere in the country outside of New Mexico.

Given the thermal properties of thick adobe wall construction, which allows for less use of energy for cooling and heating, adobe builders were

creating environmentally friendly "green" homes well before there was a call for such a thing. Many of the homes were built with bricks made on-site, reducing the need for shipping.

In the early 1980s, the state of California made significant changes to building codes – most notably seismic restrictions – which slowed the adobe building boom. As a result, though homes have been built featuring non-structural adobe brick facades, the era of true adobe home construction came to an end. Because adobe houses will never be built on a large scale again in California, the collection of existing homes across San Diego's North County is a finite treasure that requires the stewardship of people willing to maintain these now-irreplaceable structures, according to the San Diego Adobe Heritage Association.

The Adobe Home Tour is a volunteer effort of that association, whose mission is to inspire the appreciation and understanding of adobe heritage in San Diego County. From its earliest days, settlers of southwestern California have appreciated the practical and aesthetic values of adobe home construction, and today's adobe aficionados across San Diego County are eager to grow awareness of the uniqueness of these architecturally significant structures. The San Diego Adobe Heritage Association maintains a website which serves as a resource for homeowners looking to remodel, restore or maintain their adobe home, or for anyone with an interest in adobe construction.

Complete with a train ride, a visit from the Easter Bunny, and an Easter egg hunt, the *Easter Bunny Train* event at the museum is per-

fect for the whole family. These special trains will run Saturday and Sunday, April 4 & 5, and Saturday, April 12. (The usual Golden State Trains will run on Easter Sunday, April 21, but **no** Bunny Trains that day.)

The *Easter Bunny Trains* will run at 11 a.m., 1:15 p.m., and 3 p.m. Any unforeseen modifications to the hours will be posted on the home page of the PSRM website (**www.psrm.org**).

Tickets are available for sale NOW for the *Bunny Trains*, and associated events. Those tickets can be purchased in-person the day of the event, at the Campo Depot (<u>subject to space availability</u>), or online at the PSRM website: **www.psrm.org**. Note: Advance reservations are <u>not</u> required for this event. (See listing of ticket fares, below.)

The celebration kicks-off with a train ride. The Easter Bunny will board the train at the Campo Depot and visit with all of the passengers on the train as it travels through San Diego's beautiful east-county mountains. After enjoying the one-hour journey along 12 miles of track, the train stops at the museum's Display Building where more fun awaits.

Within the Display Building two Easter egg hunting areas will be open for the children. One is geared towards the smallest travelers, with eggs in plain sight; the other takes-up the entire Display Building, with eggs carefully hidden by the Easter Bunny. The children may turn-in the plastic eggs they find to museum volunteers for sweets, and other prizes. The best part – entrance into the Display Building, and either of the Easter egg hunts, are included in the price of your train tickets!

Locomotive Cab Rides

Locomotive Cab Rides are also offered, at \$40 per person, for one or two persons, ages 6 and up. (Persons under age six are allowed to ride in the train, but **not** in the locomotive.) This is your opportunity to ride in the locomotive cab with the engineer and the crew during the round-trip. During the ride, you'll get to experience what railroading is like from the cab of the locomotive! Cab riders under the age of eighteen (18) must be accompanied by another paid cab rider *over* the age of eighteen (18) at all times when riding in the cab.

The cost of the cab ride also includes the train ride, for a to-

tal of \$40 round-trip for every person riding in the locomotive <u>regardless of age</u> (<u>only two persons at a time</u>). PSRM does allow sharing, whereby one person rides in the cab and another on the train, during the outward-bound trip, then they switch positions for the return trip. Only two riders are allowed in the cab at one time. (For more options, or to reserve your cab ride, see the "Locomotive Cab Rides" page in their website.) Note: **Dress warmly**, in layers. Children tend to be especially sensitive to the loud air horn on the locomotive, so PSRM does have ear protection available when a child (ages 6 and up) is riding in the cab. Also, depending on which locomotive they're using, you may be required to stand for the entire trip. Closed-toed shoes are required for those riding in locomotive cabs.

NOTE: all PSRMA facilities are smoke-free environments to help promote a healthy family atmosphere. For details, and driving directions to PSRM's Campo complex in East County, see the PSRM website (above).

and place set by the Board of Directors. The meeting shall be held at a site somewhere in San Diego or Imperial Counties, either by invitation of a member organization or by arrangement of the President. The primary purpose of the Annual Meeting is for the general membership to vote for the elected officers of the next Board of Directors.

- 8.2 Regular Meetings. The Board of Directors of the Corporation shall meet at least four times a year, at such place as the officers shall designate. The Board may consider motions or suggestions from members in attendance at these meetings. A simple majority vote of the Board of Directors in attendance shall be needed for a motion to pass.
- 8.3 Special Meetings. The President or other Officer may call for a Special Meeting at any time, for any purpose. Notice of a Special Meeting must be sent in writing by surface mail, and/or as an attachment via electronic mail, at least thirty (30) days in advance to the Board Members and general membership. Such notice shall specify the nature of the business to be discussed, and discussion will be limited to that topic alone.
- 8.4 Quorum. A simple majority of the Board of Directors [half, plus 1] shall constitute a quorum for the transaction of business at any Regular or Special Meeting of the Board of Directors. No vote by proxy will be accepted. If less than a majority is present at a meeting, a simple majority of the Board Members present may adjourn the meeting without further notice.

ARTICLE IX - PARLIAMENTARY AUTHORITY

- 9.1 Rules of Order. The rules contained in the edition of Robert's Rules of Order shall govern the Corporation in all cases in which they are applicable and in which they are not inconsistent with the Corporations Bylaws or Standing Rules.
- 9.2 Parliamentarian. The President may appoint a Parliamentarian to advise him or her during his or her term of office.

ARTICLE X – BYLAWS

- 10.1 Operating Procedures. These Bylaws are the fundamental rules that apply to the Corporation's orderly operation.
- 10.2 Amending the Bylaws. These Bylaws may be altered, amended, repealed, and/or replaced by a two-thirds vote of Members in Good Standing present at any Regular, Annual, or Special Meeting of the Corporation, provided that this notice to amend the Bylaws was sent in writing to the membership via or electronic mail in writing at least thirty (30) days prior to the meeting.

ARTICLE XI – STANDING RULES

- 11.1 Standing Rules. These are procedural rules related to the details of the administration of the Corporation.
- 11.2 The Standing Rules are temporary in nature and can be adopted, altered, or rescinded by a majority vote of the Board of Directors at a Regular or Special Meeting without previous notice.

ARTICLE XII – FISCAL RESPONSIBILITY

- 12.1 Membership Dues. The Board of Directors shall review and adjust the amount of Annual Membership Dues from time to time.
- 12.2 Payment of Dues. Annual Membership Dues shall be payable to the Corporation by members of each class by the end of July.
- 12.3 Corporation Finances. The fiscal year of the Corporation shall commence on the first day of January and end on the last day of December in each year. The Treasurer shall prepare and present financial statements to the Board of Directors at each Regular Meeting, as well as an Annual Report for the membership at the Annual Meeting. The Corporation's financial records shall be subject to membership inspection at any time. Annual Financial Reports shall be available to the public.
- 12.4 Contracts. The Board of Directors may authorize any officer, or Committee Chairperson to enter into any contract, or execute and deliver any instrument in the name of, and on behalf of, the Corporation, and such authority may be general or confined to specific transactions. A written copy of this authorization will be executed and given to the Treasurer and the officer or Committee Chairperson making the contract on behalf of the Corporation. In turn, a copy of any contract made on behalf of the Corporation shall be forwarded to the President with a copy to the Treasurer.
- 12.5 Checks, Drafts, Etc. All checks, drafts or orders for the payment of money, notes, or other evidences of indebtedness issued in the name of the Corporation, shall be signed by such officer or officers, agent or agents of the Corporation in such manner as shall from time to time be determined by resolution of the Board of Directors. In the absence of such determination by the Board of Directors, such instruments shall be signed by the Treasurer.
 - 12.6 Deposits. All funds of the Corporation shall be deposited by the Treasurer receipt to the credit of the Cor (Continued on Page 26)

Museum Month is NOW active!! San Diego residents and visitors are invited to enjoy half-price admission at 45 museums during *THIS* February. To take advantage of this great cost savings you must pick-up a *FREE* Museum Month Pass at libraries in San Diego County (for a library list see the website address, at the end of this article). One pass is good for up to four half-price admissions at each museum, so you can take family or friends, too!

Forty five museums are taking part in this offer. All 45 museums are members of the San Diego Museum Council, so look through their website (www.sandiegomuseumcouncil.org) to find information on any museum you choose to visit! Keep the Museum Pass and use it all month long!

Museum Month was created by the San Diego Museum Council in 1989 to promote awareness of the region's museums, historical sites, educational institutions and cultural offerings. Since that time the promotion has grown to become a cultural tradition on a level witnessed by very few cities in the country. The Museum Month Pass will be available for pick-up at libraries in the San Diego area **beginning Friday**, **February 1**, **2019** (check the website at the bottom of this article for a list of the participating libraries).

Whether you are an art aficionado, history buff, or nature lover, *Museum Month* offers a variety of museums that are bound to capture your interest. Take advantage of this annual program to visit both old favorites and new attractions you have never even heard of! The roster of museums spans the likes of the Adobe Chapel, Barona Cultural Center & Museum, Birch Aquarium at Scripps, Bonita Museum & Cultural Center, California Center for the Arts (Escondido Museum), California Surf Museum, Coronado Museum of History & Art, Fleet Science Center (Galleries only), Flying Leatherneck Aviation Museum, Gaslamp Museum at the Davis-Horton House, Heritage of the Americas Museum, Japanese Friendship Garden, Junipero Serra Museum, La Jolla Historical Society, Living Coast Discovery Center, Lux Art Institute, Maritime Musum of San Diego, Marston House Museum & Gardens, Miniature Engineering Craftsmanship Museum, Museum of Contemporary Art San Diego, Museum of Making Music, Museum of Photographic Arts, New Americans Museum, Oceanside Museum of Art, Old Mission San Luis Rey Museum.

poration in such banks, trust companies or other depositories as the Board of Directors may select. The signatories on these depositories should include the Treasurer and two other Board Members.

12.7 Donations. The Board of Directors may accept on behalf of the Corporation any monetary contribution, gift, bequest, etc., to fulfill its mission. All donations and their value will be reported to the Treasurer for auditing purposes.

ARTICLE XIII - PROPERTY AND DISSOLUTION

13.1 Property and Asset Ownership. The property and assets of the Corporation shall be vested in the persons comprising the Board of Directors. No part of the assets or the net income of the Corporation shall be accrued for the benefit of an individual Board Member. All property and assets of the Corporation shall be recorded and reflected in the Corporation's financial statements.

13.2 Dissolution. Upon the dissolution of this Corporation, any assets remaining after payment of, or provision for payment of all debts and liabilities of this Corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for educational or historical purposes and which has established its tax exempt status under Section 501(c) (3) of the Internal Revenue Code. The Board of Directors shall make the decision, with a simple majority vote, regarding to whom the money will be distributed.

KNOW ALL YE: That we, the undersigned, being duly elected or appointed members of the BOARD OF DIRECTORS of the CONGRESS OF HISTORY OF SAN DIEGO & IMPERIAL COUNTIES, hereby assent to the foregoing Bylaws and adopt them as the Bylaws of this Corporation.

not be sold. He finally got enough granite to build his own home, a cute, two story cottage. (See photo on page 18 and, on this page, Edna on her front porch, left. Photos courtesy LHS.) This handbuilt home was recently listed on the County Registry of Historic Places. She lived there until her passing.

Edna alsoserved the community as President of the Lakeside Elementary and Grossmont High School PTA and in 1959 became the first President of the El Capitan High School PTA in Lakeside. She served on the Lakeside School Board for three years and was a substitute teacher in Lakeside, Santee, and Alpine School Districts for 20 years. Her family did a lot of camping, fishing and hunting and they cooked everything that they caught!

Edna was a founding member of the Lakeside Historical Society in 1972. The organization met in various places around town. Finally, in 1986, Edna was on the committee that made a proposal to purchase the Olde Community Church, which had been built in 1896. It was a worry to the Historical Society members, would they be able to pay off the mortgage or would they leave a problem for their heirs? [At the age of 71] Edna was the chairman of the restoration committee and she ran a tight ship; within four years they had paid-off the mortgage! Edna was a wonderful woman who cared for her family, community, and friends for 105 years. She will be missed. . . . Her husband predeceased her; she is survived by her three children. Services are pending.
